#### NARRATIVE

ON 08/07/2014 I RESPONDED TO 13785 SW 42ND COURT ROAD, IN REFERENCE TO ASSISTING THE DRUG UNIT WITH A SEARCH WARRANT. I WAS MADE AWARE THAT A SUBJECT, LATER IDENTIFIED AS DEFENDANT DERRICK PRICE, RESIDED AT THE RESIDENCE AND HAD THREE FELONY WARRANTS FOR HIS ARREST (MCSO CASE# 14019108, 14019320, 14019843).

AS UNITS ARRIVED ON SCENE, THE DEFENDANT WAS OBSERVED EXITING THE REAR OF THE RESIDENCE AND RUNNING EASTBOUND FROM THE RESIDENCE. K-9 DEPUTY COLLINS, ID 4192, ARRIVED ON SCENE, AND BEGAN A TRACK WITH HIS K-9 PARTNER "SIG", OF THE DEFENDANT. DEPUTY COLLINS TRACKED THE DEFENDANT TO THE AREA OF THE 100 BLOCK OF MARION OAKS BLVD. THE DEFENDANT WAS SEEN RUNNING EAST ACROSS MARION OAKS BLVD AND WAS CAPTURED BY DEPUTY TERRELL, ID 4981, DEPUTY CRAWFORD, ID 5223, DEPUTY HOPPEL, ID 5422, AND AGENT FITZGERALD, ID 4934.

I ARRIVED ON SCENE SHORTLY AFTER AND OBSERVED THE DEPUTIES ATTEMPTING TO HANDCUFF THE DEFENDANT. I OBSERVED THE DEFENDANT LYING ON HIS STOMACH WITH ONE ARM UNDERNEATH. I COULD CLEARLY HEAR THE DEPUTIES TELLING THE DEFENDANT TO STOP RESISTING, AND ALSO TELLING HIM TO REMOVE HIS ARM FROM UNDERNEATH HIS STOMACH. THE DEPUTIES WERE ABLE TO GAIN CONTROL OF THE DEFENDANT AND PLACE HIM UNDER ARREST.

I TRANSPORTED THE DEFENDANT TO TIMBERRIDGE HOSPITAL IN REFERENCE TO INJURIES HE RECEIVED FROM THE INCIDENT. THE DEFENDANT RECEIVED STITCHES TO LACERATIONS ON HIS FACE. AFTER THE DEFENDANT WAS CLEARED FROM THE HOSPITAL, I TRANSPORTED HIM TO THE MARION COUNTY JAIL WITHOUT FURTHER INCIDENT.

LIEUTENANT TURNER, ID 2276, ARRIVED ON SCENE AND WILL COMPLETE THE GREEN TEAM IN THIS CASE.

**\*\*FOLLOW UP\*\***

ON 08/07/2014, I, AGENT FITZGERALD, WITH THE UNIFIED DRUG ENFORCEMENT STRIKE TEAM, RESPONDED TO 14310 SW 39 COURT ROAD, TO ASSIST WITH THE EXECUTION OF A SEARCH WARRANT. AGENTS WERE ALSO EXECUTING A SEARCH WARRANT AT DERRICK PRICE'S HOUSE, WHO IS THE DEFENDANT OF THIS CASE LOCATED AT 13785 SW 42 COURT ROAD. WHILE SEARCHING THAT RESIDENCE, I WAS ADVISED DERRICK PRICE WAS SEEN EXITING HIS RESIDENCE AND FLED FROM THE S.W.A.T TEAM. AT THAT TIME, DETECTIVES CRAWFORD, HOPPEL AND I STARTED BOLO'ING THE AREA, ALL IN THE SAME VEHICLE. WE WERE ADVISED THE DEFENDANT WAS POSSIBLY IN THE AREA OF THE ABC ACADEMY LOCATED AT 13865 SW 36 AVENUE ROAD. WHILE ON PERIMETER IN THE AREA OF THAT LOCATION, WE OBSERVED K-9 DEPUTY T.COLLINS WITH HIS K-9 PARTNER "SIG", TRACKING THE DEFENDANT TOWARDS A THICK BLOCK OF WOODS BEHIND THE BUSINESS. "SIG" TRACKED INTO THE BLOCK OF WOODS AND A SHORT TIME LATER, WE OBSERVED THE DEFENDANT RUN EASTBOUND FROM THE BLOCK OF WOODS THAT "SIG" TRACKED TO. THE DEFENDANT THEN RAN ACROSS MARION OAKS BLVD AND INTO A PARKING LOT. AT THAT TIME, DEPUTY TERRELL, DETECTIVE CRAWFORD, DETECTIVE HOPPEL, AND I ATTEMPTED TO TAKE THE DEFENDANT INTO CUSTODY. WHILE TRYING TO HANDCUFF THE DEFENDANT, I WAS ABLE TO GET THE DEFENDANT'S RIGHT ARM BEHIND HIS BACK, BUT THE DEFENDANT HAD HIS LEFT ARM UNDER HIM AND AFTER SEVERAL VERBAL COMMANDS TO THE DEFENDANT TO STOP RESISTING AND TO PUT HIS HAND BEHIND HIS BACK THE DEFENDANT STILL WOULD NOT PUT HIS HAND BEHIND HIS BACK. DEPUTY TERRELL, DETECTIVE HOPPEL AND DETECTIVE CRAWFORD WERE ASSISTING ON GETTING THE DEFENDANT'S ARM BEHIND HIS BACK. FINALLY AFTER SEVERAL ATTEMPTS AND VERBAL COMMANDS OFFICERS WERE ABLE TO GET THE DEFENDANT'S LEFT HAND BEHIND HIS BACK SO HE COULD BE HANDCUFFED. THERE WAS INFORMATION FROM A CONFIDENTIAL SOURCE THAT THE DEFENDANT HAS MADE STATEMENTS IN THE PAST THAT HE HAS GUNS AND HE IS NOT GOING BACK TO JAIL. THE DEFENDANT ADVISED IF THE COPS COME TO TRY AND GET HIM HE WILL BAG IT OUT WITH THE COPS. THERE WAS CONCERN DURING THE ENTIRE INCIDENT THAT THE DEFENDANT MAY HAVE BEEN ARMED AND DANGEROUS BECAUSE OF THE STATEMENTS THAT HE MADE TO A CONFIDENTIAL INFORMATION.

**FOLLOW UP**

ON 8-7-14, I WAS ASSISTING AGENT FITZGERALD, WITH THE UNIFIED DRUG ENFORCEMENT STRIKE TEAM, AT 14310 SW 39 COURT ROAD WITH THE EXECUTION OF A SEARCH WARRANT. AGENTS WERE ALSO EXECUTING A SEARCH WARRANT AT THE DEFENDANT'S RESIDENCE LOCATED AT 13785 SW 42 COURT ROAD. WHILE SEARCHING THE LOCATION THAT I WAS ASSIGNED TO, I WAS ADVISED THAT THE DEFENDANT, DERRICK PRICE, WAS SEEN EXITING HIS RESIDENCE AND FLED FROM THE S.W.A.T TEAM.

AT THAT TIME, AGENT FITZGERALD, DETECTIVE HOPPEL AND I STARTED BOLO'ING THE AREA, ALL IN THE SAME VEHICLE. WE WERE ADVISED THE DEFENDANT WAS POSSIBLY IN THE AREA OF THE ABC ACADEMY LOCATED AT 13865 SW 36 AVENUE ROAD. WHILE ON PERIMETER IN THE AREA OF THAT LOCATION, WE OBSERVED K-9 DEPUTY T. COLLINS WITH HIS K-9 PARTNER "SIG" TRACKING IN THE AREA OF A THICK BLOCK OF WOODS BEHIND THE ABC ACADEMY. K-9 "SIG" TRACKED INTO THE BLOCK OF WOODS AND A SHORT TIME LATER, WE OBSERVED THE DEFENDANT RUN EASTBOUND FROM THE BLOCK OF WOODS ACROSS MARION OAKS BLVD AND INTO A PARKING LOT. AT THAT TIME, DEPUTY TERRELL, AGENT FITZGERALD, DETECTIVE HOPPEL, AND I ATTEMPTED TO TAKE THE DEFENDANT INTO CUSTODY. WHILE TRYING TO HANDCUFF THE DEFENDANT, AGENT FITZGERALD WAS ABLE TO GET THE DEFENDANT'S RIGHT ARM BEHIND HIS BACK, BUT THE DEFENDANT HAD HIS LEFT ARM UNDER HIM AND AFTER SEVERAL VERBAL COMMANDS TO THE DEFENDANT TO STOP RESISTING AND TO PUT HIS HAND BEHIND HIS BACK THE DEFENDANT STILL WOULD NOT COMPLY. IT APPEARED THAT THE DEFENDANT WAS TRYING TO EITHER PUSH UP WITH HIS LEFT ARM OR CONCEAL SOMETHING UNDER HIM. I THEN ATTEMPTED TO UTILIZE SEVERAL KNEE STRIKES TO THE DEFENDANT'S LEFT UPPER LEG IN ORDER FOR HIM TO COMPLY WITH OUR COMMANDS. AFTER UTILIZING THE KNEE STRIKES THE DEFENDANT FINALLY COMPLIED AND AGENT FITZGERALD WAS ABLE TO PUT HANDCUFFS ON THE DEFENDANT.

IT SHOULD BE NOTED THAT DURING THE BRIEFING PRIOR TO THE EXECUTION OF THE SEARCH WARRANTS, AGENT SAMS ADVISED THAT THERE WAS INFORMATION FROM A CONFIDENTIAL SOURCE THAT THE DEFENDANT HAS MADE STATEMENTS IN THE PAST THAT HE HAS GUNS AND HE IS NOT GOING BACK TO JAIL. THE DEFENDANT ADVISED IF THE COPS COME TO TRY AND GET HIM HE WILL "BAG IT OUT" WITH THE COPS. THERE WAS CONCERN DURING THE ENTIRE INCIDENT THAT THE DEFENDANT MAY HAVE BEEN

ARMED AND DANGEROUS BECAUSE OF THE STATEMENTS THAT HE MADE TO A CONFIDENTIAL INFORMATION.

DEPUTY AMIDEI THEN RESPONDED TO THE LOCATION AND TOOK POSSESSION OF THE DEFENDANT.

**FOLLOW UP**

ON 08/07/2014, I WAS ASSISTING THE UNIFIED DRUG ENFORCEMENT STRIKE TEAM AT, 14310 SW 39 COURT ROAD WITH THE EXECUTION OF A SEARCH WARRANT AS A MEMBER OF THE MARION COUNTY SHERIFF'S OFFICE S.W.A.T TEAM. AT THIS TIME A SEARCH WARRANT WAS ALSO BEING EXECUTED AT THE DEFENDANT'S RESIDENCE LOCATED AT 13785 SW 42 COURT ROAD. WHILE STANDING ON THE PERIMETER OF THE LOCATION THAT I WAS ASSIGNED TO, I WAS ADVISED THAT THE DEFENDANT, DERRICK PRICE, WAS SEEN EXITING HIS RESIDENCE AND FLED FROM THE S.W.A.T TEAM.

AT THAT TIME, AGENT FITZGERALD, DETECTIVE CRAWFORD, AND I STARTED BOLO'ING THE AREA IN AGENTS FITZGERALD'S VEHICLE. LISTENING TO GIVEN UPDATES BY K-9 DEPUTY COLLINS AND AGENTS FROM THE UNIFIED DRUG ENFORCEMENT STRIKE TEAM ON THE POSSIBLE WHEREABOUTS OF THE DEFENDANT WE WERE ADVISED THE DEFENDANT WAS POSSIBLY IN THE AREA OF THE ABC ACADEMY LOCATED AT 13865 SW 36 AVENUE ROAD. WHILE ON PERIMETER IN THE AREA OF THAT LOCATION, WE OBSERVED K-9 DEPUTY COLLINS WITH HIS K-9 PARTNER "SIG" TRACKING IN THE AREA OF A THICK BLOCK OF WOODS BEHIND THE ABC ACADEMY. I THEN OBSERVED K-9 "SIG" TRACK INTO THE BLOCK OF WOODS AND A SHORT TIME LATER, I OBSERVED THAT THE DEFENDANT RAN EASTBOUND FROM THE BLOCK OF WOODS ACROSS MARION OAKS BLVD. AT THIS TIME I SAW DEPUTY TERRELL ALSO RUNNING ALONG THE WOOD LINE IN THE DIRECTION TOWARD THE DEFENDANT. DEPUTY TERRELL THEN JUMPED INTO THE BACK OF AGENT FITZGERALD'S VEHICLE AS THE DEFENDANT CONTINUED ACROSS THE STREET INTO A PARKING LOT. AT THAT TIME DEPUTY TERRELL, AGENT FITZGERALD, DETECTIVE CRAWFORD, AND I ALL DROVE UP NEXT TO THE DEFENDANT IN A ATTEMPTING TO TAKE THE DEFENDANT INTO CUSTODY. DURING THE TAKEDOWN THE DEFENDANT WAS INITIALLY STANDING WITH BOTH HANDS VISIBLE TO OFFICERS AS I WAS GIVING LOUD VERBAL COMMANDS FOR THE DEFENDANT TO SHOW US HIS HANDS. THE DEFENDANT THEN TURNED HIS BACK TOWARDS OFFICERS AT WHICH TIME HIS HANDS WERE NO LONGER VISIBLE. AGENT FITZGERALD AND I WERE ON THE DEFENDANT'S RIGHT SIDE TRYING TO GAIN CONTROL OF THE DEFENDANTS RIGHT ARM AT WHICH TIME A BRIEF STRUGGLE ENSUED. AGENT FITZGERALD AND I GAINED CONTROL OF THE DEFENDANT'S RIGHT ARM AT WHICH TIME AGENT FITZGERALD PLACED HANDCUFF ON THE DEFENDANT'S RIGHT ARM. OFFICERS WERE UNABLE TO GAIN CONTROL OF THE DEFENDANT'S LEFT ARM WHILE CONTINUING TO GIVE VERBAL COMMANDS FOR THE

DEFENDANT TO STOP RESISTING AND TO GIVE OFFICERS HIS HAND. OFFICERS CONTINUED TO STRUGGLE WITH THE DEFENDANT TO SECURE THE DEFENDANTS LEFT HAND AND TO SEE IF THE DEFENDANT WAS ARMED OR NOT. AFTER A LONG STRUGGLE WITH THE DEFENDANT OFFICERS WERE ABLE TO SECURE THE DEFENDANTS LEFT ARM AND SECURE THE DEFENDANT IN HANDCUFFS. DEPUTY AMIDEI RESPONDED TO THE LOCATION AND TOOK CUSTODY OF THE DEFENDANT. I THEN RESPONDED BACK TO 14310 SW 39 COURT ROAD.

IT SHOULD BE NOTED AT THE INTELLIGENCE BRIEFING BY THE UNIFIED DRUG ENFORCEMENT STRIKE TEAM THEY ADVISED THAT ALL OFFICERS INVOLVED SHOULD USE EXTREME CAUTION WHEN DEALING WITH THE DEFENDANT. MEMBERS OF THE TEAM ADVISED OFFICERS THAT THE DEFENDANT HAS AN EXTENSIVE CRIMINAL HISTORY AND IS TO BE CONSIDERED ARMED AND DANGEROUS. MEMBERS OF THE TEAM ADVISED OFFICERS THAT THE DEFENDANT HAS MADE STATEMENTS TO A CONFIDENTIAL SOURCE THAT THE DEFENDANT HAS GUNS AND HE IS NOT GOING BACK TO JAIL. THE DEFENDANT ADVISED TO THE CONFIDENTIAL SOURCE THAT IF COPS COME TO TRY AND GET HIM HE WILL "BANG IT OUT WITH THE COPS".

THIS WILL CONCLUDE MY INVOLVEMENT IN THIS CASE.
